### **Under the following conditions:**

Rock Llewelin Setters has put a lot of time and effort into carefully raising this puppy. The sire and dam had been mated with the purpose of producing quality and healthy puppies suitable for hunting. RLS will provide the purchaser with Field Dog Stud Book application papers, this day or within a reasonable amount of time, at no extra cost. The purchaser will also receive with the dog and Bill of Sale, its Health Record, Nutrition Information, Spay and Neuter Information, Recommendations, Familiar Commands and Schedule, and Unofficial Pedigree (official may be obtained from the FDSB).

The buyer must be the person who will be keeping the dog; RLS will not sell a dog as a gift or surprise to a third party. RLS' liability is limited to, and in no event shall exceed, the purchase price of the dog involved. The purchaser is advised to have the dog examined by his or her own veterinarian within 3 days of the receipt of the dog in question and send a copy of the examination/record to the breeder within one week of the examination. If a previously unknown problem is found during the recommended post-purchase vet exam that resulted directly because of the breeder, the buyer should contact the breeder within 24 hours, and possible solutions may be discussed. Should the buyer neglect the examination within the specified time period, RLS will accept no liability for any health concerns, as it will be the buyer's responsibility to maintain the good health of the pup, of which it was sold. The dog will be guaranteed to be free from hereditary hip/joint troubles until the age of three years.

The purchaser promises to keep the dog in a proper and healthy manner. It shall be given the maximum amount of time possible for exercise, and it shall have access to fresh water and quality dog food. Buyer will take his/her dog to receive veterinary care, when appropriate. Appropriate times may include emergencies, vaccinations, etc. By the time the buyer has received the puppy, it will have started a series of vaccinations and dewormings that will need to be completed by buyer's veterinarian. Buyer will not breed the dog before it reaches two years of age.

This Llewelin may not be sold or given away without expressed written and signed agreement from the breeder. If there is a time when the dog must change homes, the breeders have prior purchase rights at that time for a period of two weeks. The selling of the dog to a third party is only allowable after prior consultations with RLS, so that breeders may be sure that the dog will be living in an acceptable home. This Llewelin may not be placed in a rescue or shelter; should an emergency arise when buyer is no longer able to keep said dog, buyer is to contact breeder. The purchaser is responsible for notifying the breeder if there is a change of address, so that contact is possible if needed.
